In accordance with 4 CMC Division 7, §7112, I am pleased to present the 30th Annual Report of the Insurance Commissioner.

This report includes a listing of admitted insurers and a summary of insurance business transacted in the CNMI from all admitted alien, foreign and domestic carriers during the 2017 calendar year.

During the reported year, the Office of the Insurance Commissioner issued Certificate of Authority (COA) and licensed and regulated:

- Two (2) alien carriers;
- Fifty-One (51) foreign carriers;
- Eleven (11) domestic carriers;
- One hundred fifty-six (156) insurance licenses for general agent, sub-agent, broker, surplus lines broker and adjuster.

No new Certificate of Authority (COA) was issued for alien insurer.

One (1) new COA was issued to an admitted foreign company:

Travelers Property Casualty Company of America

No new COA was issued for a domestic insurer.

One (1) insurers were granted permission to withdraw their COA from doing business in the insurance market was:

GPM Health & Life Insurance Company formerly known as North Coast Life Insurance Company

Highlights from this report:

Direct premiums written for Property and Casualty experienced a 6.3% increase from \$30.8 million to \$32.8 million. Direct losses incurred increased by 1.8% from \$12.8 million in 2016 to \$13 million in 2017.

Commissioner's Summary of 2017

The Office of the Insurance Commissioner (OIC) continues to pursue its mission which is "Protecting CNMI consumers through regulation, monitoring and education, while providing oversight of the insurance industry to best serve the public." The Office of the Insurance Commissioner (OIC) is a regulatory division directly under the authority of the Secretary of Commerce who serves as the Insurance Commissioner.

The division continues to monitor the fiscal health or financial solvency of all admitted insurers and the compilation of various reports. As part of this review, insurers are required to file annually an audited financial statement which is in accordance with the general form and context as approved by the National Association of Insurance Commissioners (NAIC) and an annual statement with the required "State Page Report" reflecting all insurance business of the insurer in the CNMI for the prior year ending December.

It is crucial to ensure that regulations requiring fair, equitable and safe business practices are in place and are enforced for the betterment of the citizens of the Commonwealth.

In September July of 2016, public law 19-56 which establishes the implementation of the Claims and Clinical Data Warehouse (CCDW), with the authority to coordinate health information exchange (HIE) and all-payer health insurance with local health care agencies however, during the promulgation of regulations the law was repealed in January 14, 2107 and reenacted by PL-19-78. Nonetheless, the implication would have established that Commonwealth Healthcare Corporation, CNMI Medicaid Program and the Insurance Commissioner to cooperate on the governance of the claims database. Certainly, this was only months and may have inadvertently been an oversight.

The OIC continues to seek guidance through the National Association of Insurance Commissioner for the continuance of regulatory training for the critical needs of the CNMI and its applicability of immerging issues.
